# Conformity of Production (CoP)

# Why CoP is important?

The data shows that China's auto exports have continued to grow, reaching a record 4.426 million units in 2023, and as China's auto exports continue to grow, the product conformity risks faced by Chinese auto brands and their supply chains have also increased. Therefore, it has become a top priority for Chinese automobiles to understand the legal and regulatory requirements of the importing countries and implement production conformity

in accordance with the reguirements. In addition, with the development of electric vehicles and intelligent driving technology, the automotive industry is also facing new safety challenges. One out of every two cars exported in China is an electric vehicle, making the conformity of production of new energy vehicles an important topic. All of this has an impact on Chinese car brands and even the international image of Made in China.

# The legal and regulatory basis for CoP

Regulation (EU) 2018/858

Approval and market surveillance of motor vehicles and their trailers, and of systems, components and separate technical units intended for such vehicles.

Conformity of production is one of the cornerstones of the EU type-approval system, and therefore the arrangements set up by the manufacturer to ensure such conformity should be approved by the competent authority or by an appropriately qualified technical service designated for that purpose and should be subject to regular verification by means of independent periodic audits. In addition, approval authorities should ensure the verification of the continued conformity of the automotive products concerned.

Ensuring product conformity in series production is becoming an increasingly important component of production, especially in terms of approvals. In order to achieve this, compliance with the legal regulations in series production is mandatory, which is regularly checked by various state or licensing authorities.
